#### Biographies: Chair & the Academy's President



Professor Sir Aziz Sheikh OBE FRSE FMedSci Aziz Sheikh is Professor of Primary Care Research & Development at the University of Edinburgh and is a global leader in primary care research, bringing the rigour of randomised trials into practice and exploiting the use of information technology, developing crucial Bayesian methodologies to assess the utility of IT solutions in clinical practice. He has led globally on the epidemiology and management of anaphylaxis. He brought allergy research into primary care and led the development of UK, European and international guidelines. He also leads research on asthma management in General Practice and led UK research into ethnic differences in health in primary care.



Professor Andrew Morris CBE FRSE, FMedSci Professor Andrew Morris is the President of the Academy of Medical Sciences and Professor of Medicine, and Vice Principal of Data Science at the University of Edinburgh. His research interests span informatics and chronic diseases. In August 2017, he became the inaugural Director of Health Data Research UK (HDR UK), the UK's national institute for health data science. HDR UK works in partnership with the NHS, industry, charities and universities to realise the potential of the UK's health data in life-changing research. Andrew was Dean of Medicine at the University of Dundee (2012-2014) and Chief Scientist at the Scottish Government Health Directorate (2012-2017). He has served and chaired numerous national and international grant committees and Governmental

bodies, including the Scottish Government's COVID-19 Advisory Group. Andrew was previously Governor of the Health Foundation (2009-2017), a leading UK charity that supports quality improvement in health care, and chaired the Informatics Board at UCLPartners, London (2014-2017). In 2007 he cofounded Aridhia Informatics, which uses high-performance computing and analytics in health care.

## Speaker biographies



**Dr Simon Royal** is currently the Primary Care Chief Investigator for the infant RSV study, HARMONIE. He was the National Primary Care Lead for the NIHR clinical research network (CRN) before it's restructuring into the research delivery network (RDN). At the RDN, he still represents primary care research and is passionate about bringing research into primary care settings. He has over 20 years of research experience, including urgent public health COVID-19 vaccine trials. He also has an advisory

in the Vaccine Innovrolen Pathway. His specialities are preventative medicine, mental health, and respiratory medicine. Dr Simon Royal is a Partner at Cripps Health Centre and a full time GP.



**Dr Natalie Vassilouthis** is currently Global Medical Lead (RSV) at Sanofi. She has over a decade of experience as a medical doctor with broad clinical experience. She has a strong background in medical affairs within vaccines and infectious diseases, both at affiliate and global level. Dr Vassilouthis is experienced in shaping and delivering strategic priorities, including leading a large-scale phase 3b study.

**Emily Ahmed** is a qualitative researcher and community engagement facilitator, specialising in creative and participatory approaches, patient and public involvement and the coproduction of health and social care research. Having worked for over 25 years across the charity and voluntary sector, NHS, local authorities and academia in the UK and internationally, she brings extensive experience designing and delivering applied research and service improvement. Passionate about tackling health inequities, Emily has particular interest

and expertise in using co-production, the creative arts and participatory methods. She also specialises in maternity, women's health, children and families, mental health and long-term conditions. Previous work history includes peer Research Manager at Newham Public Health, Freelance Co-Production Consultant. As a PhD Researcher at Warwick University, her research explored the ways power is understood, experienced and shared (or not shared) and how systems and structures intersect with experiences of power within the co-production of UK health research.



Ruby Nayyar is a Community Researcher in T2 Diabetes for Public Health Newham. She is a Newham community member with lived experience of supporting family members with Type2 Diabetes. Ruby is part of a team of Newham Public Health Community Researchers, all of whom have strong connections within the borough and have been trained in a range of qualitative research methods. Ruby has been involved in co-producing community research in Newham and has collaborated with fellow researchers and academics from The University of Oxford, with whom she co-authored a journal article, 'Identifying areas for

action to create healthier diets in the London Borough of Newham; systems mapping with local residents'. She is also a Nutrition & Wellbeing coach, qualified L3 Anatomy & Physiology Yoga and Dance instructor and co-Author of "How to Eradicate Diabetes." She majored in a BA (Hons) in Professional Writing and Design Management from The University of West London and previously worked in Journalism. Ruby has a strong passion and background in nutrition and fitness and has been involved in the health, wellbeing, and fitness industry for over two decades.

Professor Laura Shallcross MBE is National Institute of Health and Care (NIHR) Professor of Public health and Director of the UCL Institute of Health Informatics. She led the national VIVALDI study, which informed the public health response to COVID-19 in care homes and was a member of the Scientific Advisory Group for Emergencies (SAGE) Social Care working group. Laura leads a collaborative, inter-disciplinary programme of research which is focused on reducing the impact of infections,

outbreaks and antimicrobial resistance in health and social care. Her research is delivered in partnership with patients, care home residents, their relatives, care home staff, and care providers. She is strongly committed to translating research findings into policy and practice and works closely with national policymakers.
