## TOWARDS BETTER SAFETY ASSESSMENT OF MEDICINAL PRODUCTS: A FORUM PROJECT

Advances in human genomics research, together with the sequencing of the main laboratory animal species, are providing biomedical scientists with an important opportunity to understand the causes of disease and the factors that determine the response to therapy. The safety assessment of medicines remains a major public concern but it will be possible to provide better predictions of the risk of adverse reactions. It is the aim of this Project to survey the current status in the assessment of the safety of medicinal products and to identify scientific opportunities to improve assessment.

#### Dr Geoffrey Schild and Dr Gwyn Morgan lead this major Project, which extends from the pre-clinical disciplines involved in early drug development through to the pre-marketing phases of clinical development to "pharmacovigilance" and related activities postmarketing. It brings together some 70 experts from industry, academia and regulatory bodies and aims to produce a draft report for consultation by May 2004.

#### **NEW TOPICS FOR 2004**

A list of new topics suggested by Forum members was discussed at the Advisory Board meetings on 12 September and 8 December 2003. Topics like *Biomarkers of Disease and Disease Susceptibility* and *Who Prescribes*? are still under consideration but the following have now been confirmed:

• **Can Europe compete in biomedical research?** Sir Tom McKillop, Chief Executive of AstraZeneca, will deliver the second Annual Forum Lecture on Wednesday 31 March 2004 at 10 Carlton House Terrace, London SW1. The entry is free of charge.

• **Medicines for Children** – a symposium to be held on 14 June 2004 in London. The symposium will bring together experts from industry, academia and the regulatory authorities. The programme will include four sessions including 1) Requirements and Resources to be chaired by Professor Alasdair Breckenridge, *Chairman of the Medicines and Healthcare products Regulatory Agency;* 2) Technical, scientific and medical issues to be chaired by Professor Patrick Vallance, *Head of Medicine, University College London;* 3) Practical experience with clinical trials in children to be chaired by Professor Sir Colin Dollery, *Senior Consultant, GlaxoSmithKline;* and 4) Unmet needs and parental concerns to be chaired by Professor Sir Michael Rawlins, *Chairman of the National Institute for Clinical Excellence*.

• **Obesity and Diabetes** – a Medical Science Briefing to be held in autumn 2004. This first briefing may become part of a series aimed at informing the press of the Academy Forum's view on recent research developments in new diseases. These short events will bring together four experts from academia and industry, and will be followed by a debate.
